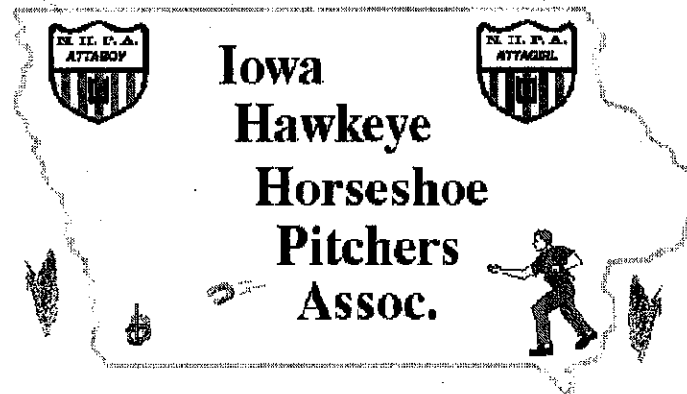

He and I were the final pitchers and I beat him by a whisker. We became very good friends. I pitched against him many years and I don't think I ever beat him again. Irvin was a very interesting man. He could talk for hours about games he had played in the past and would go in detail such as what he did on the 3rd, 6th and 9th pitch of a game six months previous. He had a mind in that direction that would get the attention of anyone, especially me who couldn't remember what I did yesterday.

About 20 years ago, they wanted us to take them to the State Fair. They had never been there and they couldn't go by themselves. So Izzy and I took them. Irvin played on my 4-man team. You'd have thought that we had given them the farm.

About four years ago, I made a special trip to visit him. I hadn't seen him for probably 10 years. His wife said he's out in the garden. When he straightened up, just that quick he said, "Ruusss." It shocked me, a man in his 90s and hadn't seen me in a long time.

They lived in lime springs and raised a very big family. The end of another era.

## CALL FOR NOMINATIONS

It is time to solicit nominations for our Association's Hall Of Fame and Frank Jackson Awards.

**Hall of Fame Award:** The purpose of the Hall of Fame Award is to honor and perpetuate the names of those members who have displayed outstanding ability in the game of horseshoes and/or who have contributed through meritorious service to the general welfare and progress of the game and/or who have pitched horseshoes for a great numbers of years. The successful candidate must receive 75% of the vote cast with a minimum of seven members voting. There can be multiple successful candidates, and there may be no nominee if the 75% vote is not met. Members inducted into this select group consider this to be a great honor, and many continue to promote the sport of horseshoes.

**Frank Jackson Award:** This award is given to that person who has given effort above the call of duty in advancement of horseshoe pitching in Iowa. Only one successful candidate by majority vote.

Hall of Fame and Frank Jackson Awards are elected by the Hall of Fame Board which consists of the Executive Board of IHHPA, Regional Chairpersons, and a Nomination Committee appointed by the IHHPA President. The nominations for the Awards are from you, the Membership, by submitting a brief description of accomplishments and reasons you feel your candidate deserves the recognition. If you know individuals that fit the criteria for either of the above awards, please send information to me. Include in your nomination their name, how long they have been actively involved with horseshoes, their specific accomplishments and things you feel that make these horseshoe pitchers special. These nominations do not need to be lengthy. In fact, we appreciate nominations that are concise and to the point.

The committee needs your help identifying these individuals so their efforts may be properly recognized. No awards were given in 2009 or 2010. There are five nominees carried forward from last year for the Hall of Fame award; there is no current nominee for the Frank Jackson Award.

## IHHPA HALL OF FAME ROBERT "BOB" WALTERS

Robert Walters was born on a farm in Grant Township, Hardin County, Iowa on September 6, 1920. He was raised on his family's farm just Northeast of Eldora. Bob graduated from Eldora High school, with wrestling and ping pong his best subjects. Bob went to the State Wrestling Tournament twice.

Bob served in the United States Army during World War II. He was stationed in the Philippines and Yokohama during the Japanese Occupation, and walked the streets of Hiroshima during his stay.

Bob farmed with his dad and raised hogs. In 1967, during the Hog Cholera outbreak, Bob had to dispose of much of his herd. It was a very difficult time in his life. In 1968, he got his license to sell real estate. He moved his family to Eldora in 1976 to start his own real estate business. His largest sale was a farm for \$1,050,000.

Bob attended the Iowa State Fair one year and watched Ralph Simon and others pitch on the courts. At this time, Eldora had four courts and Ernie Daleske and Ray Teske were regular pitchers there. They all started pitching together, and eventually talked the city into putting lights at the courts. In 1981, the group went to Spencer to attend the Clay County Fair. It was there that Bob won his first trophy. From then on, he was hooked on horseshoes. The three teamed up with Morris and Joe Lepley and established the Eldora Club.

During a trip to the World Tournament in Ainsworth, Nebraska, Bob had a chance to visit with the legendary Ted Allen. Ted Allen asked Bob, "When is Iowa going to do something for Putt Mossman?" Soon after, the Eldora Club was thinking about a spot for winter-time horseshoes. They went to several city council meetings and were given a pledge for \$8,000. Then in 1988, they learned that the Hardin County Fair Board was considering a new Exhibit Building on the Fairgrounds. Bob attended a Fair Board meeting and was asked to be on the Fair Board.

For almost three years, the Eldora Club solicited funds and pledges from horseshoe pitchers. In the Spring of 1990, Bob and Cliff Kenney then Secretary / Treasurer, attended a meeting with the Fair Board and the Hardin County Board of Supervisors. Shortly afterwards, the County pledged \$45,000 for the building. That pledge, along with the City's pledge of \$8,000 and pledges from horseshoe players, paid for the construction of the Putt Mossman Indoor Pitching Arena.

Bob has also served as Regional Director for Iowa. He enjoyed going to all the tournaments and meeting all the good people from Iowa and other states. At Bob's invitation, World Champions Kevin Cone and Allen Francis gave pitching demonstrations at the Putt Mossman Arena.

Bob was awarded the Frank Jackson award in 1991. He was named the Hardin County "Fair Person of the Year" in 1995. Bob has pitched in three World Tournaments - - Ainsworth, Nebraska; Pleasanton, California, and Spearfish, South Dakota. He has pitched at numerous Iowa Games, including the Iowa Winter Games which are held each year at the Putt Mossman Arena.

Bob and his wife, Faith, have five children - - Gregg, Angie, Gordon, Anita and Chuck.
