CONDOLENCES

Harold Floyd Darnold of Burlington, Iowa, passed away December 19, 2007, in Iowa City.

Born March 30, 1925 in West Burlington., Harold was a Burlington Northern Machinist Locomotive Inspector for 17 years. He also worked at Camp Cleaners for 25 years. He served in the Air Force during World War II and was the last surviving member of the crew that manned the B-17 named *Ray's Hell*, which carried a horseshoe on every mission.

He was director and manager of the Iowa Corn Belt Horseshoe Tournament in Crapo Park starting in 1954. He was inducted into the IHHPA Hall of Fame in 1982, and into the NHPA Hall of Fame in 1994.

He was runner up at the State Championships in 1980 and 1982. He placed third in the Intermediate Class at the World Championship in 1990, throwing 59.6%.

Harold <u>Garner</u>, of Melrose, said that people would get him and Harold <u>Darnold</u> mixed up at tournaments. Harold Garner also said that Harold Darnold was a fun guy to pitch against.

Harold was also an avid billards player and bowler. In 1964 and 1965 he was the straight pool city champion. The pallbearers at his funeral were the members of his pool team. His family held the funeral reception at Whitey's Bar and Billards in Burlington.
