The following By-laws proposals will be heard and voted upon:

By Law Proposal # 1
ARTICLE VII (STATE CHAMPIONSHIP REQUIREMENTS)
SEC 7 (SCHEDULE)

Present language reads: Competition for the State Championships in the men, women and junior events shall be on weekends whenever possible.

Proposed: (Add the following new language that appears in **Bold print** to Section 7 (Schedule):

Competition for the State Championships in the men, **ELDERS**, women and junior events shall be on weekends whenever possible.

Proposed:

In case there is a full or partial rainout the tournament will be rescheduled by the Executive Board for the following weekend with the location and times determined by the Executive Board. If the rescheduled weekend is rained out, the Executive Board will decide when the next weekend of tournament play will be held.

Reason:

For clarification in the By Laws as to how State Championship Rainouts will be dealt with.

By Law Proposal # 2
ARTICLE VII (STATE CHAMPIONSHIP REQUIREMENTS)
SECTION 1 (QUALIFICATIONS)

Proposed: Add the following new language to the present Qualification language:

All pitchers participating in the Iowa State Championship Tournament must wear a shirt with their name neatly lettered on the back at least 1 inch high. No alcohol or tobacco of any kind shall be permitted within the confines of the courts. This information shall appear on the State Tournament Entry Form and the entrant agrees to conform to this requirement.

Reason: Three reasons - (1) Scorekeepers not knowing the participants will be able to identify them; (2) spectators will be able to identify them and be able to compare the score on the scoreboard with a name; and (3) The professional image of horseshoe pitching is enhanced.

By Law Proposal # 3 ARTICLE V (DUES)

Present Language: The annual dues for men and women of this association shall be thirty-one (\$31.00) dollars, which includes NHPA current dues and the IHHPA Newsletter. Dues for one additional adult member living at the same address shall be twenty (\$20.00) dollars, which includes NHPA current dues. Limit of one additional adult per household. Dues for junior boys and junior girls shall be seven (\$7.00) dollars, which includes NHPA current dues. The association dues card shall be issued for the calendar years January 1st through December 31st. A player is considered a junior the entire season if his 18th birthday

occurs on or after the start of the calendar year, January 1st.
"PRO - RATED DUES" will be allowed for an Adult or
Junior for a specified period of July 1st through December
31st. The IHHPA dues for this period is waived and the
individual will pay only the current annual NHPA dues
amount. Only those who have never been a member of the
NHPA would be eligible for this "Pro-Rated" dues period.

Proposed By Law change:

Remove the sentence: " Dues for junior boys and girls shall be seven (\$7.00) dollars, which includes NHPA current dues."

Replace this sentence with: Junior membership is free. The IHHPA will pay the NHPA portion of the dues for all Juniors. Remove " or Junior " from the Pro Rated Dues language in the sixth line from the bottom.

Reason:

Hopefully this will increase the number of Junior participants in the IHHPA.



CONDOLENCES

Maurice Skinner of Lucas, Iowa passed away at age 91. He pitched horseshoes from 1960 to 1990. He was with the Russell team at the 1990 State Fair. He owned Skinner Store at Norwood, ten miles North of Lucas, and had a set of stakes along the Highway.

John Fraaken of Des Moines passed in July, 2011. John was a U.S. Army Veteran and retired Iron Worker. He was a member of the IHHPA and Central Iowa Traveling League for many years.

Earl Winston passed away August 8, 2011. Earl was a U.S. Army veteran, and served a tour of duty in Korea. Earl was a horseshoe pitcher nearly all of his life and was a former Missouri State Champion. He was elected a vice president of the NHPA and served in that position for 28 years.
