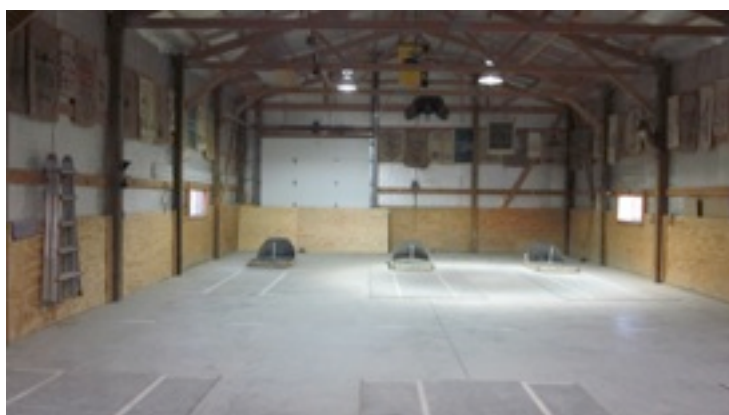

### SPRING IS HERE!

The 2013 Outdoor Pitching Season will soon be here, with the first outdoor tournament scheduled in Indianola on May 4th. There are tournaments scheduled every weekend throughout the Spring, Summer, and Fall, ending with the October 12th tournament in Winterset.

Ron and Mary Jane Stanerson hosted two indoor tournaments in March in Marengo. Classes D, E, and F pitched on Saturday, March 16th. Classes A, B and C pitched on Saturday, March 23rd. Eldora will finish the indoor season with tournaments on April 6, 7, 13 and 14.

### CALL FOR NOMINATIONS

It is time to solicit nominations for our Association's Hall of Fame and Frank Jackson Awards. Deadline for nominations is July 12, 2013.

Hall of Fame Award: The purpose of the Hall of Fame Award is to honor and perpetuate the names of those members who have displayed outstanding ability in the game of horseshoes and/or who have contributed through meritorious service to the general welfare and progress of the game and/or who have pitched horseshoes for a great number of years. The successful candidate must receive 75% of the vote cast with a minimum of seven members voting. There can be multiple successful candidates, and there may

be no nominee if the 75% vote is not met. Members inducted into this select group consider this to be a great honor, and many continue to promote the sport of horseshoes.

Frank Jackson Award: This award is given to that person who has given effort above the call of duty in advancement of horseshoe pitching in Iowa. Only one successful candidate by majority vote.

Hall of Fame and Frank Jackson Awards are elected by the Hall of Fame Board which consists of the Executive Board of IHHPA, Regional Chairpersons, and a Nomination Committee appointed by the IHHPA President. The nominations for the Awards are from you, the Membership, by submitting a brief description of accomplishments and reasons you feel your candidate deserves the recognition. If you know individuals that fit the criteria for either of the above awards, please send information to me. Include in your nomination their name, how long they have been actively involved with horseshoes, their specific accomplishments and things you feel that make these horseshoe pitchers special. These nominations do not need to be lengthy. In fact, we appreciate nominations that are concise and to the point. The committee needs your help identifying these individuals so their efforts may be properly recognized.

Joe Smith and Owen Simmons were inducted into the Hall of Fame in 2012. Other IHHPA Hall of Famers are Keith Baker (2011); LeRoy Law (2008); Harold Garner (2007); Leo Buell (2005) and Marv Engstler (2004). Past winners of the Frank Jackson Award are Steve Ronk (2012); James Jackson and Stoney Jackson (2011); Bob Bown (2008); Leo Buell (2007); Dave Sidles (2006); Bob and Marian McKee; (2005); Mic Wilson (2005); and Dick Walker (2002).

### CONDOLENCES



**Glen Speers** of Grandview passed away February 9, 2013 at Veterans Affairs Medical Center in Iowa City. Glen was born January 7, 1937 in South Dakota. He worked at General Motors in California and JI Case in Bettendorf, and served in the United States Navy during the Korean War. He later owned and operated a recycling salvage business.

Glen played horseshoes for many years, mainly in the Iowa City/Cedar Rapids area. He won the 30-foot State Championship in 2011.

Glen is survived by his wife, Janice, one son, Jim Speers, and two daughters, Jalen Farr and Amy McIntyre.



**Robert "Bob" Walters** of Eldora passed away February 12, 2013. Bob was born September 6, 1920 in rural New Providence, Iowa. He served his country in the United States Army from 1945 until 1946.

Bob married Faithe Bonnicksen in 1949 and they raised five children. Bob worked as a farmer and raised purebred hogs until 1967, when he lost his hogs due to cholera.

He later went on to get his real estate license and opened Walters Real Estate in Eldora. He continued to work in real estate until he was in his mid-80s.

Bob started pitching in the 1980's and was one of the original members of the Eldora Horseshoe Club. During a trip to the World Tournament in Ainsworth, Nebraska, Bob had a chance to visit with World Champion Ted Allen. Ted Allen convinced Bob that Bob should do something to recognize Putt Mossman, World Horseshoe Champion and stunt man from Eldora.

Shortly afterwards, the Eldora Club was thinking about a spot for Winter-time horseshoes. In 1988, the members of the Club were invited to a Hardin County Fair Board meeting to discuss a new Exhibit Building to be built on the Fairgrounds. Bob then approached his fellow horseshoes players, the Hardin County Board of Supervisors, and the City of Eldora to gather pledges for the building. On May 1, 1991, Bob and many other IHPA members attended the ground breaking ceremony for the Hardin County Youth Building which would house the Putt Mossman Arena for indoor horseshoe pitching.

Bob was awarded the Frank Jackson Award in 1991 and was elected to the IHPA Hall of Fame in 1995. In his nomination papers, it was noted that Bob was always a very good sport. He attended many tournaments throughout the state and was always ready to lend a helping hand. In Bob's own words, "Horseshoes have changed my whole life and I will continue to work and promote for the good of the sport."

Bob is survived by his wife, Faithe, sons Gregg, Gordon and Chuck, and daughters, Angie and Anita.

**James ("Jim") D. Kempes** of Urbandale, Iowa, passed away March 6, 2013. Jim was born in Everette, Washington in 1924, and grew up in Pella, Iowa. He served in the U.S. Navy during World War II and was commissioned as a lieutenant. *continued next page*



Jim graduated from Central College and married Marian Brown. They lived in Pleasantville, where Marian taught high school biology and Jim hitchhiked to his law classes at Drake University in Des Moines. After obtaining his law degree in 1949, he moved to Des Moines, and worked as a lawyer for Iowa-Des Moines National Bank, then its successor, Norwest Bank. He retired in 1986 and joined Marian in operating their Pella business, Menning Imports. He served as an elder at Westminster United Presbyterian Church, helped with scout programs and Y Indian Guides, and served as President of the Des Moines Society of Financial Analysts. He was awarded dozens of medals at the Iowa Games and Iowa Senior Olympics for swimming, track and field, horseshoe pitching, and basketball shooting. In 2007 Jim was inducted into the Iowa Senior Olympics Hall of Fame.

He was preceded in death by his wife, Marian, who died in October, 2012. He is survived by four sons, Mark, Bruce, David and Brian.

**Edward V. Osterkamp** of Alcester, South Dakota, passed away on February 28, 2013.

Edward was born July 2, 1930 in Rockford, Iowa. He moved to Ireton, Iowa at the age of six and grew up on a farm. He served with the United States Army during the Korean Conflict and returned home in 1954. He married Joan Vander Hamm in November of 1954, and they farmed for 18 years in the Ireton, Hawarden and Alcester areas. In 1969 the couple moved to Alcester where Ed worked for the City of Alcester, and later retired as a custodian at Peace Lutheran Church.

Ed loved pitching horseshoes. He was an avid player for many years and had participated in 18 World Tournaments, winning 1st twice and placing seven other times. He was inducted into the South Dakota Horseshoe Hall of Fame in 2011.

Ed is survived by his wife, Joan, six children, 14 grandchildren and 11 great-grandchildren.

**IHPA HALL OF FAME  
OWEN SIMMONS**



Owen A. Simmons was born on November 17, 1917 in Eldora, Iowa. He graduated from Colwell High School in 1937 and then attended Hamilton Business College in Mason City. Owen married Iverne Johnson on August 22, 1942 in Charles City.

On October 22, 1942, Owen left for active duty with the U.S. Army. He served as a Technician Fifth Grade with the 363rd Infantry. He was wounded on September 17, 1944 during the Battle of North Appenies in Italy. Owen was discharged on December 22, 1945. He was awarded the Purple Heart, ETO Ribbon with One Battle Star, Good Conduct Medal and Combat Infantry Badge.

Owen was tournament Director for singles and doubles tournaments held during the Big Four Fair in Nashua until the courts were removed. Owen also built two horseshoe courts at Cedar Lake Park in Nashua. He pitched in tournaments in Charles City, Osage, Mason City, Nora Springs, Waverly, Eldora, Cedar Falls, Waterloo, Independence and Boone. He also pitched in tournaments in Minnesota and Wisconsin. He pitched in the World Tournament when it was held in Des Moines.

Owen injured the first three fingers on his right hand in a job accident and had to have metal pins put into his fingers. He learned to pitch all over again using rubber horseshoes pitching from 10 feet from the stake and gradually moving back.

Owen had grandchildren that liked to pitch horseshoes with him, most notable - Steven Meyer, Debra Meyer and Laurie Meyer, all Iowa State Junior Champions, and Chad Simmons. His great granddaughter, Samantha Meyer, became California State Junior Girls Champion in 2011. Also, two great granddaughters are just starting to pitch - Lynda and Callie Taylor of Center Point. Owen passed away February 2, 1994.
