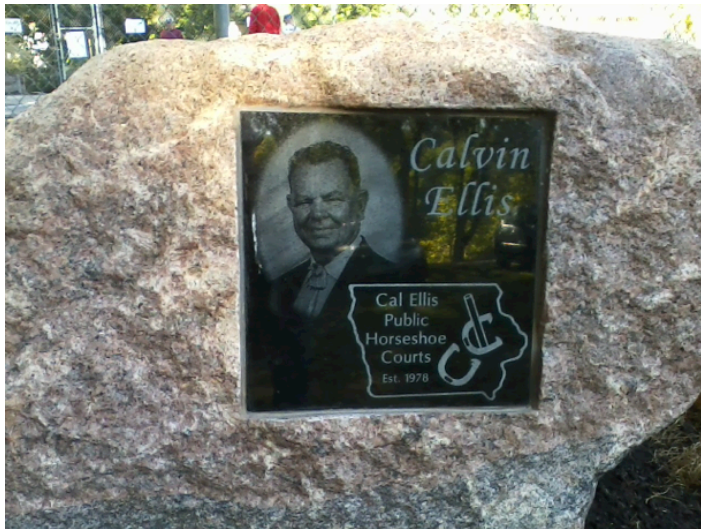


**CAL ELLIS MEMORIAL TOURNAMENT
FORT DODGE, IOWA**



The second annual Cal Ellis Memorial Horseshoe Tournament was held September 21ST at the Hydro-Electric Park in Fort Dodge. The park is located on the west bank of the Des Moines River near 1st Street NW and 4th Avenue NW.

Tournament Director Marty Sprague was pleased with this year's turnout of 22. Contestants were divided into 4 classes of players of similar ability for lots of fun and friendly competition.

Class A was won by Glenn Warden of Grimes shooting 57.5% against some of the top pitchers in Iowa. That included current 40 foot Iowa State

Champion Dave Mittlestadt. Class B was won by new IHHPA member Bud Johansen of Gowrie at 46%. Marv Dirks of Fonda won Class C with 32.5%. Jack Navin of West Des Moines broke a three way tie for 1st place in Class D with Jake Clair of Colo and Dick Marsh of Fort Dodge by shooting 24% for the day.

Ryan Maehl, recreation administrator of the Fort Dodge Parks, Recreation And Forestry Commission has worked closely with Sprague in relocating and up grading the horseshoe courts. Sprague was instrumental in obtaining a grant from the Iowa Hawkeye Horseshoe Pitchers Association for part of the cost. He has also headed an evening league and encouraged 10 new pitchers to join IHHPA this year. Parks & Rec recently placed a large decorative stone in honor of local horseshoe great Cal Ellis at the site.
