#### REMEMBERING CARL



Carl was born on March 13, 1923, in Des Moines, Iowa. He was educated in the Des Moines Public Schools and graduated from East High School where, like many from his family, he excelled in track. Following graduation, Carl enlisted in the United States Army and served in the Pacific theater during WWII. He was awarded the Purple Heart for his

faithful and courageous service. After receiving an honorable discharge, he returned to Des Moines to begin civilian life.

At a young age, Carl married Sylvia Forrester-Kaiser. From this union, six children were born. Later in life, he married Rosalie Robinson-Kaiser. From this union, he was blessed with six additional children. Carl was a dedicated family man, the consummate father, and remained faithful to his paternal duties until his passing. He was described as being liberal in his parenting, but never permissive.

Carl excelled in many activities and possessed a wealth of knowledge. His knowledge extended into medicinal herbs, medicines, and homeopathic cures. Physically, he was still the family pull up champion in his 90's. He could seemingly effortlessly pitch a horseshoe from forty feet until the time of his passing. His absolute favorite pass time was attending the

Drake Relays. He attended every year except while he was overseas serving in the Army. Those who attended his memorial service will enjoy telling you about his "Kansas City cousins".

Carl was introduced to competitive horseshoe pitching by fellow US Post Office employee, Danny Sease in 1990, 28 years ago. He pitched in the Tuesday night Central Iowa Traveling Horseshoe League and also pitched in the Wednesday night league. In the fall, he pitched in the Wednesday night sanctioned league. For years, he attended most Eldora Indoor Tournaments and regularly helped set up and tear down the courts during the winter. Carl assisted three different lowa State Fair Superintendents of Horseshoes for over 20 years and was the longest ever member of the Fair's horseshoe grounds crew. For years, he has been among the leaders of the most IHHPA tournaments played. LeRoy Law believes that Carl has probably pitched at every court location in Iowa. He has pitched in the State Championship Forty Foot Class at the Iowa State Fair many times and has probably pitched in all other pitching events at the Fair. He has participated in several World Tournaments and traveled to other states to pitch in major tournaments. In 2015, Carl was inducted into the Iowa Hawkeye Horseshoe Pitchers Hall of Fame.

We will miss Carl's laugh, his smile, his friendly disposition on and off the court, and his advice. He has been an extraordinary true credit to the sport of horseshoes and the IHHPA. Most of all, he has been a great friend.



#### **2018 National Sanctioned League Tournament**

Four lowa teams participated on October 6<sup>th</sup> and 7<sup>th</sup> in the tournament which was held in Wentzville, Missouri, at the Quail Ridge Horseshoe Club Courts, where the NHPA Hall of Fame is located. The tournament was run "count-all" and "handicapped" at 92.5% with 50 shoe games. Teams came from seven different states. Twenty teams pitched for over \$5,000 in prize money. The three-person teams were divided (ten teams each) into a Scarlet Division and a Gray Division. Each team played six games on Saturday and three games on Sunday. The first four places were "in the money". The two division winners then played for the championship.

In the Scarlet Division, Team Cedar Rapids finished in first place for the third year in a row. (Bert and Larry were on the 2016 championship team). Congratulations, Team Cedar Rapids! Unfortunately, they lost in the championship round to the winners of the Gray Division, a team from Missouri. Team Marengo finished in sixth place in this same division.

In the Gray Division, Team West Des Moines #1 finished in fourth place (but "in the money"). Team West Des Moines #2 finished just one point behind them in fifth place (and not "in the



money"). In this same division, Kristy Klejch earned \$100 for pitching the highest game over her average. (There is one winner in each division.) Kristy pitched great all weekend! She had

one 60% game which was 19.94% over her average. Congratulations, Kristy!

#### **HIGHLIGHTS OF 2018 NHPA RULE CHANGES**

Submitted by Deb Davis

- 1. II. Requirements, Requirement 2, Section B Eligibility. Two new levels of memberships will be available to new members for the calendar year January 1, 2019 to December 31, 2019. (See details of Trial memberships and Provisional memberships listed on bottom of 2019 IHHPA MEMBERSHIP FORM on page 6 of this issue.)
- 2. II. Requirements, Requirement 2, Section F League Play: All seasonal sanctioned Club/League play must be two hundred (200) or more pitched shoes to quality as an official event. *This has changed from 400 shoes.*
- 3. Rule 2E, Section E Court Rotation. At the end of each game, contestants can practice on the current court until their next assigned court is available. After games on adjacent courts are completed, both pits shall be prepared for play. When the scorekeeper is ready, the contestants have the option of pitching no more than 4 additional warm up shoes each, and then the next game must begin immediately.
- 4. Rule 11 Tournament .League Play. Class ties . . . total points may be used (to determine the winner) if the scoring was done using the count-all method.
- Requirement 6, Cadets and Juniors, Additional Information
   Section C Awards. Awards presented to a Junior or Cadet by the Tournament /League Officials may have immediate or deferred monetary value.
  - Section D Amateur Status. Prizes or cash awards for horseshoe pitching achievements do not impact amateur status in any NCAA sport (horseshoe pitching is not an NCAA Sport). It is the responsibility of the youth participant and their parents/guardians to check state scholastic sport association regulations/restrictions when determining whether to accept an award with any monetary value. The host charter and/or the NHPA assumes no responsibility for any adverse effects which Horseshoe pitching awards may have on the amateur status of a youth participant.

**NOTE:** NHPA members can now present proposals for rules and bylaw changes on an annual basis. This year you have until November 30, 2018 to present them. In subsequent years, the deadline will be September 30 to allow time for proper review. The proposed changes should be submitted in a format that quotes the current rule and then lists the proposed wording. Then the reason for the proposed change should be provided.
