### THANKS FOR THE MEMORIES

When I asked Danny Sease about his involvement in horseshoes, he submitted an autobiographical timeline. I enjoyed reading it. I hope that you will also. Chris Jordan



Danny said:

Born in 1939, I was a Letter Carrier for 37 years and received a 50-year Gold pin for membership in the union. I have played horseshoes for 44 years. Over the years I have enjoyed the friends in horseshoes I have made in Des Moines, in Iowa and over the USA. This has truly been a journey of love. Also, I thank my family, my wife and 4 girls for their support all these years.

1972 Started pitching horseshoes at Birdland Park in Des Moines. Purchased my first horseshoe membership card.

1973 Played in tournament in Oregon. At the fall IHHPA meeting at Air Lanes bowling alley introduced the ringer percentage system used in Oregon to Iowa. Elected Secretary-Treasurer of IHHPA and served six years (1974-1979). My wife and I served as statistician and newsletter editors for the IHHPA also. Dave Shaffer helped with the newsletter. This is where qualifying by playing in tournaments began in Iowa. No more qualifying on the day of the tournament anymore.

1974 Became Superintendent of Horseshoe Pitching at The Iowa State Fair and served one year then became assistant to Marion Lange until 1979. The Iowa State Fair horseshoe event was held inside the sheep barn in years 1968-1973. In 1974, it was moved outside because the IHHPA executive committee asked them to do so. It was located on the old teen town site east of the midway. This year Dick Huitt, Keith Baker and myself started the Greater Des Moines Horseshoe League at Birdland. It would be there until the flood of 1993.

The purpose of this association shall be to provide an orderly means for its members to participate in and enjoy the game of horseshoe pitching, to encourage interested parties in organizing local clubs, leagues, or to form other groups for participation in horseshoe pitching for play or tournament and assist wherever possible in the promotion of horseshoe pitching as a game or sport in the State of Iowa. The association shall have unlimited power to engage in and to do any lawful act concerning any or all-lawful business for which associations may be organized - - *IHHPA Bylaws*

- 1974 This year also the NHPA Secretary-Treasurer Walter Ray Williams Sr was traveling through Iowa on the way to the World Tournament on the east coast. We arranged an exhibition at Birdland Park between World Champion Junior Champ Walter Ray Williams Jr and the Iowa State Junior Champion Jerry Sease and invited the news media. Paul Beaman also participated along with Jeff Williams second in the world. The Williams family camped in my yard and was interviewed by the Des Moines Register. Thus, talk of a World event in Des Moines began.
- 1976 Wrote a letter to the Greater Des Moines Chamber of Commerce asking for support for a World Tournament. We received a guarantee of \$10,000 in prize money and any other help needed to secure a bid.
- 1977 My nephew, Paul Beaman, and I went to the World Tournament in Greenville, Ohio. There I met the NHPA and began talking about Des Moines. Paul qualified first in the junior event.
- 1978 When no bid was received for the 1978 World Tournament, it was offered to Des Moines. We accepted. Became Co-Chairperson of the 1978 W.T. and received NHPA Achievement Award. With help of the Greater Des Moines horseshoe league, we held the World Tournament at the Iowa State Fairgrounds and Birdland Park. 200 from Iowa entered the tournament and our membership was 331 in the IHHPA. In 1973, it was 135.
- 1979 In 1979 we had around 60 tournaments. Founded the Central Iowa Team League and sanctioned by the NHPA. Selected by the league as player of the year for the organizing efforts of establishing the league. I have played in the league every year. Became the 2<sup>nd</sup> Vice President of the IHHPA and served 4 years (1980-1983).
- 1981 Inducted to IHHPA Hall of Fame.
- 1985 Became Secretary-Treasurer of IHHPA for a second time serving 4 years (1985-1988). This gave me 10 years as Secretary-Treasurer. I was also statistician while secretary. This gave me 14 years of service as an officer of the IHHPA.
- 1988 Became Co-Director of Hawkeye NHPA Regional Tournament at the Iowa State Fairgrounds.

- 1990 Awarded Distinguished Service Award at the annual meeting of IHHPA for service to the association.
- 2002 Became Superintendent of The Iowa State Fair Horseshoe Event. We have taken photos of every person awarded a ribbon over the past 15 years. Received President's Award for Tournament Director of the year.

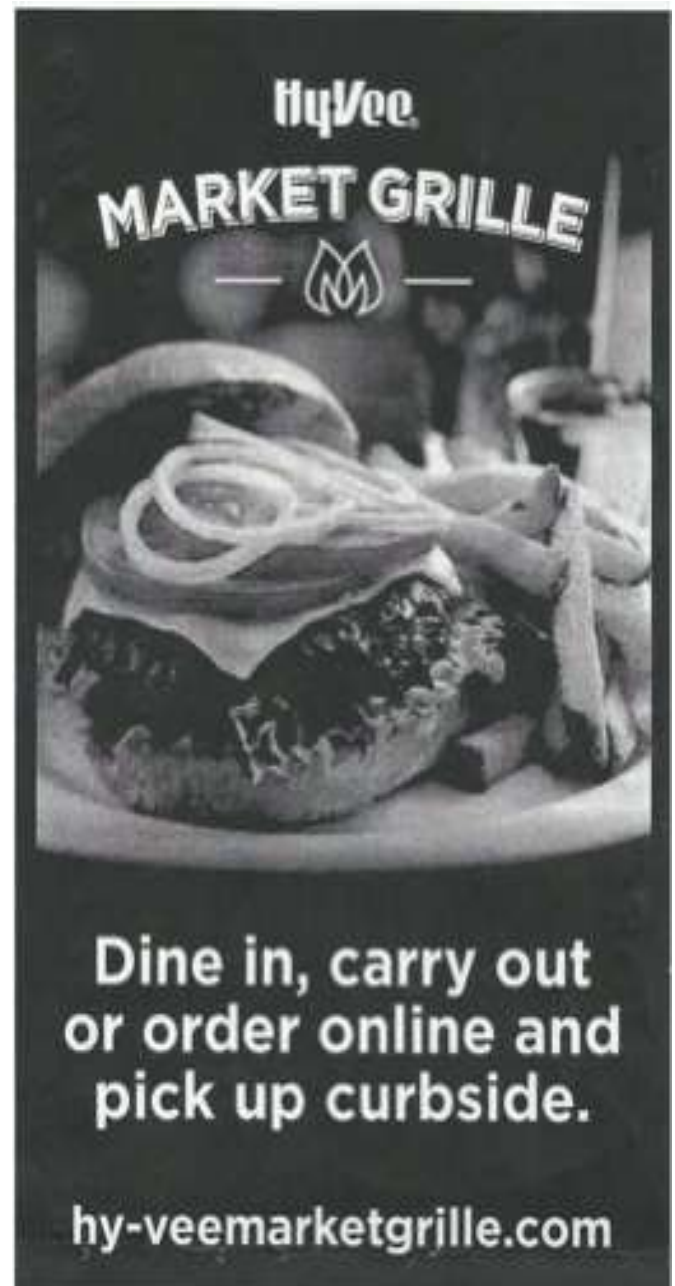

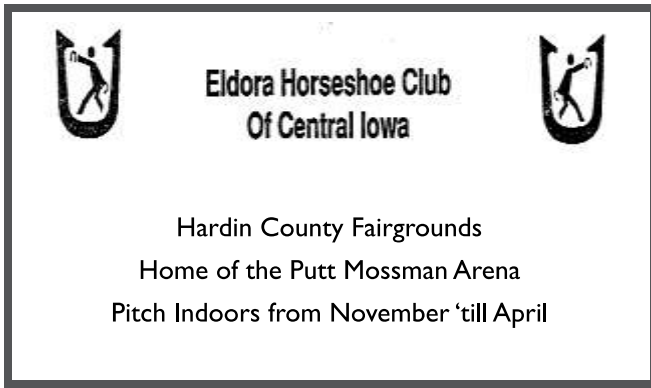
